

Privacy Policy

Independent Souls is committed to the ethical collection, retention and use of information that you provide to us about yourself (“Personal Information”) on this site www.independentsouls.org (“Site”)

Your Personal Information may comprise the following:

- your name
- your email and mailing address
- your telephone numbers
- your payment processing details
- limited personal details
- Any other data as Independent Souls may require

The following Privacy Policy sets forth our understanding with you on the collection, use and protection of your Personal Information. Please read the entire Privacy Policy.

2. While you are browsing through the Site, the Site’s operating system may automatically record some general information (“General Information”) about your visit such as:
- the date and time you visit the Site, along with the address of the previous website you were visiting
 - if you linked to us from another website
 - the type of browser you are using (such as Internet Explorer version ‘X’)
 - which ‘hit’ it is on the Site

3. The General Information is not Personal Information. Independent Souls tracking system does not record personal information about individuals or link this information to any Personal Information collected from you.

4. The General Information is used by Independent Souls for statistical analysis, for tracking overall traffic patterns on the Site and to gauge the public interest in Independent Souls and the Site. Such General Information may be shared by Independent Souls with any person, at Independent Souls’ discretion.

2. Usage of Information 1. Personal information will be used by Independent Souls for internal purposes including the following:

- sending e-mails and updates, Independent Souls Annual Report, regular updates on the utilisation of donations by Independent Souls, appreciation e-mails and other updates.
- processing your donations to Independent Souls
- maintaining an internal confidential database of all the Personal Information collected from donors and prospective volunteers/employees
- evaluating and administering the Site and Independent Souls's activities, responding to any problems that may arise and gauging visitor trends on the Site. Disclosure of Personal Information by Independent Souls

1. Independent Souls endeavours to use up-to-date security measures to protect your Personal Information.
